Attendee Agreement and Responsibilities Waiver

I AGREE TO THE FOLLOWING TERMS, LIMITATIONS & CONDITIONS (PLEASE INITIAL EACH SECTION)

I understand that participating in the "WaterBARK Day" event involves inherent risks, including but not limited to, the behavior and actions of other dog(s) and participants, potential for injury to myself, children, my dog(s), and others, as well as damage to property.

I do hereby represent and warrant that my dog(s) are spayed/neutered, in good health, current on vaccinations (including rabies, distemper, and parvovirus), and free of contagious illnesses or parasites. I will provide my vaccination records prior to entering.

I affirm that my dog(s) is well-behaved, non-aggressive, and socialized to interact safely with other dog(s) and people.

I understand that if a dog(s) defecates in the pool, the pool will be evacuated of participants, while the pool chemicals are being tested and a proper amount of time has passed.

I understand that the WaterBARK Day at Big Rivers Waterpark is a litter-free event. I agree to immediately deposit any trash or dog(s) waste in the proper receptacle.

I agree to supervise my dog(s) at all times and not to leave my dog(s) unattended in the park and/or within an enclosed vehicle.

I release any right and grant full permission to Big Rivers Waterpark to use, without payment, any photographs, videotapes, motion pictures, sound recordings, or any other record or information derived from this or any other Big Rivers Waterpark related event.

I acknowledge that I am responsible for my dog(s)'s actions and any resulting injury or damage.

In consideration of the acceptance of this entry and the allowance of myself, my dog(s) and/or my children's participation in the WaterBARK Day, I, for myself and my children, and all others who might otherwise make claim on behalf of me or my children, do hereby voluntarily assume full and sole responsibility for any injury, illness, or damage, accidental or intentional, which may occur to myself, my children, property, or pets directly or indirectly as a result of or during my or my children's participation in the WaterBARK Day.

I agree to indemnify and hold harmless Big Rivers Waterpark, BRTX, LLC, Gator Bayou Adventures and all sponsors, vendors, veterinarians/veterinary staff, and officials from any and all claims, demands, actions and cause of action whatsoever including, but not limited to, any injury, illness, or damages to myself, my children, property, or pets which might result directly or indirectly from or during my, my pets or my children's participation.
